PAYMENT DETAILS:

- Membership Year runs 1st September to 31st August each year.
- Annual subscription to SDu3a costs **£10.00**.
- Affiliation membership is **£5.00** (we require proof of main u3a membership).
- Included within your annual SDu3a membership is the **£4.00** member subscription we must pay to the Third Age Trust for insurance, guidance, advice and various other services.
- To assist members in payment of fees, we have several methods available, whichever method of payment is chosen we require the following:
 - In the case of membership **renewal** - confirmation of members' up-to-date personal details
 - In the case of **new** membership – completion of our membership form

HOW TO SUBMIT YOUR APPLICATION FORM

- Visit the membership desk at SDu3a update meeting at 9.45am on the 1st Friday each month at Saltburn Community Hall, Windsor Road, Saltburn.
- Attend the Theatre Group Coffee morning 9.45am on the 2nd Saturday of the month at Echo Hall, Emmanuel Church, Saltburn.

- Visit Saltburn or Marske Library to collect a form, complete and place in a sealed envelope, **do not include cash**. NOTE: there are no facilities to pay at the library by debit card.

TO PAY BY DEBIT CARD:

- A card reader will be available at Update, Theatre Group and any organised membership drive meetings.

TO PAY BY CASH:

- Accepted face to face only at Update, Theatre Group or any organised membership drive meetings.

TO PAY BY CHEQUE (due to closure of banks and the introduction of fees for clearing cheques we ask that you consider using other methods to pay).

- Please make cheques payable to **Saltburn District u3a** and check all details i.e. date, correct amount and signature have been completed before submitting.

GIFT AID

- If you still pay tax in the UK, you can donate a 25% of your membership subscription from your tax paid. (There is no cost to you) The main rule is that your gift aid is less than the tax amount you pay annually.
- If you are married, you can Gift Aid your own subscription and that of your spouse provided that only one joint payment is made. If your spouse is the UK taxpayer, they must complete their own Gift Aid declaration and pay from a separate bank account.
